WHEREAS

- A. Both parties are involved in the field of education, teaching research, extension and training, and share their common interest in academics by all means.
- B. Considering research potentials in Kachchh and surroundings the purpose of this MoU is to establish the Centre of development for Social and Economical Inclusion and also to develop Diaspora Centre, wherein both the parties will work together.
- C. The purpose of this MoU is to continue to develop and expand a framework of cooperation between both parties.
- D. The parties have thought it expedient to lay down the Terms and Conditions in writing as herein after to ensure proper implementation in letter and spirit of the intent of this MoU.

IT IS MUTUALLY UNDERSTOOD AND AGREED BY AND BETWEEN THE PARTIES THAT:

1. They may consider certain opportunities of faculties and students exchange programmes, academic programmed, conferences, seminars, and workshops.

2. There may be exchange of publications, research materials, Books, newsletter etc.
3. Opinions on curriculum development may be sought as and when required by either party.
4. Host of the university will bear the expenses of investing the faculty and students.
5. Modifications to this MOU shall be made by mutual consent of the parties, by the issuance of a written modification signed and dated by authorized officials, prior to any changes being performed.
6. This MOU in no way restricts either party from participating in similar activities with other public or private agencies, organizations, and individuals.
7. This MOU is not a legally binding agreement. Execution of this MOU shall create no material, financial or any other obligations and individuals.


